TERMS AND CONDITIONS

Please read this important information carefully.

Payment Schedule: A non-refundable deposit of CAD\$400.00 per person is required at the time of booking. Payment may be made by cheque or money order, payable to Odyssey Learning Adventures, or by Mastercard, Visa or American Express. Final payment is due 60 days prior to departure. All registrations for programs will be processed on a first come, first serve basis. Occasionally, additional deposit amounts may be required on certain programs.

Pricing: Prices are listed in Canadian Dollars, per person based on double occupancy. GST and provincial taxes are applicable on programs as noted. Prices are subject to change without notice due to increases in government and airport authority imposed taxes and fees, and/or applicable fuel and currency surcharges.

Transportation: Airfare to the destination is included as indicated. All internal travel is part of the program cost. We are able to assist with travel arrangements from your home if required. Please do not make travel arrangements until your program has been confirmed by Odyssey Learning Adventures.

Documentation: If you are a Canadian citizen travelling into the United States or an American citizen travelling into Canada, you will need valid proof of citizenship supported by photo identification or passport. A valid Passport is required for International travel. You will be advised of local documentation requirements in your letter of confirmation. All participants are responsible for ensuring that they have the proper documentation for entry into the destination country.

Travel Protection Plan: Odyssey Learning Adventures strongly recommends travel insurance protection. We will send you information on available trip interruption/cancellation and medical coverage with your confirmation letter. Please do not hesitate to contact our office for further details prior to booking.

Cancellations and Refunds: While Odyssey Learning Adventures will do its utmost to minimize any penalties charged, there are some irrecoverable costs associated with your program. As a guideline, the following penalties will be considered the costs incurred with cancellation:

Up to 60 days prior to departure.....	\$400.00 per person (or requested deposit)
59 - 31 days prior to departure.....	50 % of total program cost
30 days to day of departure.....	100 % of total program cost
